# What is the Role of the Delegate?

-Each member-school board may send one voting Delegate and one alternative. However, any and all board members are invited to attend. All proposed Resolutions will be brought forward to the Delegation.

-Have your local school board appoint/elect an official Delegate to attend the NHSBA Delegate Assembly and have the Delegate register using the link above.

-Have your local school board take an official vote/position on each of the Proposed Resolutions – support, oppose, abstain.

-NHSBA does not monitor local boards for their specific grants of authority and relies on each delegate to take positions consistent with their Board's authorization, therefore, the local school board should also discuss the authority of the delegate vote on amendments and amended resolutions.

#### Rules of Order- NHSBA Delegate Assembly 2023

1. The President shall preside over and be responsible for the orderly conduct of the Delegate Assembly.

2. Only Delegates, or, in their absence, their designated Alternates, may vote on matters presented at the Assembly. Non-delegate school board members may ask to be recognized to offer comment during discussion periods of the Assembly. The President may decide on her/his own initiative, or upon request of a Delegate, to recognize a person who is not a Delegate. NHSBA Board members and staff members may be called upon by the President.

3. No one may speak unless he or she has been recognized by the President.

4. Once called upon by the President, please state your name and the School Board you represent CLEARLY and SLOWLY so that the minutes of this Assembly reflect our actions in an accurate and complete fashion.

5. If multiple speakers ask to be recognized on an item, each person will be given an opportunity to speak one time before an individual is allowed to speak a second time on a given


7. The President may adjust the agenda with the consent of the majority, whether by vote or otherwise



6. All speakers should be courteous and should speak on the issue then under discussion, not to the individuals raising them.

8. When voice votes do not offer sufficient clarification, a vote will be cast upon the call of the President by raising the Orange Card provided to each Delegate at the Registration Table in the lobby. The President will appoint individuals to serve as Vote Counters when needed. When amendments are offered, the President will allow no more than one amendment to an amendment.

# Continued Resolutions NHSBA 2023

A single motion will be made to adopt these resolutions, as presented, and in a block.

Where a proposed resolution has not been recommended by the Board of Directors, no motion will be made by the Board. However, if any delegate wishes to have the Assembly consider any of those proposed resolutions, he/she may do so by motion.

Presuming a second, and with majority vote of the Assembly, the resolution(s) will be considered by the Assembly. If there is not a motion(s) made on any of the proposed resolutions which have not been recommended by the Board, the recommendation of the Board will stand.

Where a resolution has been recommended by the board, a motion will be offered by an NHSBA board officer to adopt that resolution.

New resolutions may be offered by a delegate from the floor. However, consistent with our bylaws, consideration of any such new resolution will only be allowed upon a 2/3rds vote of the Assembly. Anyone planning to bring forward a new resolution, should come forward at this time and talk to Executive Director, Barrett Christina, about the proper process for consideration.



# NHSBA Proposed Bylaws Changes

Proposed Bylaw Change – Article I:

Seeks to remove the current dues structure and replace with the following:

As of October 16, 2023, dues shall be set at the rate for Fiscal Year 2024. NHSBA will provide notice to school boards by November 1st if dues will increase for the following fiscal year.

## NHSBA Proposed Bylaws Changes


Proposed Bylaw Change #2 – Article III, Paragraph 2 – Officers

Election and Term of Office. Officers shall be elected at the annual Delegate Assembly meeting and take office following that meeting. The Nominating Committee shall submit a slate of officers at the annual Delegate Assembly. The Nominating Committee shall also submit a slate of Board of Directors members to the Delegate Assembly.

Nominations may also be made from the floor. No person shall serve more than *one two* terms in each of the four officer positions.
